This document details the changes SACWIS users will see in the 4.20 Build.

Changes to ICWA Functionality

Case Overview page – Warning Message (Defect #59524) Element 9 Federally Recognized Tribe

• The following warning message will display on Case Overview page: "One or more active case members under age 22 is missing ICWA information in Person Demographics" when at least one active case member with a calculated age less than 22 (or null DOB) does not have at least one ICWA Details record, excluding Created in Error records

Case Information → Members → Case Members (Defect #58575) Element 10 Application of ICWA

- 1. For case members with a calculated age of less than 22, or with no Date of Birth, display ICWA Status according to the following hierarchy:
 - a. Display "Missing" in bold, red font when the person has no ICWA Details record, excluding created in error.
 - b. Display "Yes" if person has at least one ICWA Details record (excluding created in error) where the Response/Outcome is Membership Verified or Eligible for Membership.
 - c. Display "Pending" if person has no ICWA Details records with a Response/Outcome of Membership Verified or Eligible for Membership AND has at least one ICWA Details record with a Possible Tribal Affiliation of Maternal, Paternal, or Both AND the Response/Outcome field is null.
 - d. Display "No" if person has at least one ICWA Details record with a Response/Outcome of Not Eligible or Possible Tribal Affiliation is None (excluding created in error), and no records that would generate a Yes or Unknown status as defined above.
- 2. Highlight Race values of Unknown or Unable to Determine
- 3. Highlight Hispanic/Latino value of Unknown

Adoption Case Impacts Element 10 Application of ICWA

- 1. ICWA record completion will be required **FOR EACH CHILD** at the following points in the life of an Adoption case:
 - a. Adoption Case creation. This will not apply to reactivation. (Defect #58547)
 - b. Adoption Case Member seal and secure. Excluding created in error records. Message will display upon selecting the seal/secure button. (**Defect #58555**)
 - c. Adoption Case Member inactivation. Excluding created in error records. Message will display upon selecting the inactivate button. (Defect #58547)

Family Case Plan Impact (Defect #58550) Element 11 Court Determination that ICWA Applies

- 1. Additional values will be added to the "Protected under ICWA" component of the Child(ren) Participating in the Family Case Plan section. Additional values:
 - a. Yes this will populate if Response/Outcome = "Membership Verified" or "Eligible for Membership"
 - b. No this will populate if Response/Outcome = "Not Eligible" AND Possible Tribal Affiliation = "None"
 - c. Not Recorded this will populate when there is no ICWA detail recorded
 - d. Pending Verification this will populate when Possible Tribal Affiliation = Maternal, Paternal, or Both AND the Response Outcome has not been recorded

Changes to Pregnancy/Parenting Tab Functionality

Changes/Additions to Pregnancy/Parenting Tab (Defect #55826) Element 38 Pregnant/Element 39 Ever Fathered or Bore Children

- 1. The below changes will be made to the Person> Medical> Pregnancy/Parenting tab:
 - a. The following numeric fields will be hidden, except where historical data exists (if data found in any, display all)
 - i. Number of Living Biological/Adopted Children
 - ii. Number of Live Births
 - iii. Number of Pregnancies
 - iv. Number of Miscarriages
 - b. The following questions will be added to the Pregnancy/Parenting tab:
 - i. Has this person ever fathered or given birth to any children? Yes/No
 - 1. If "Yes", then display additional questions
 - a. How many children?
 - b. Dropdown values: "One", "Two", "Three", "Four or more"
 - ii. How many are they currently/actively parenting?
 - 1. Dropdown values: "None", "One", "Two", "Three", "Four or more"

Impacts Related to Changes/Additions to Pregnancy/Parenting Tab All defects below relate to Element 38 Pregnant/Element 39 Ever Fathered or Bore Children

- 1. **Defect #58827:** Data fix needed to set the response to "Yes" for the new question "Has this person ever fathered or given birth to any children?" when any of the following is true:
 - a. Person has a Pregnancy record with an outcome value of "Live Birth," "Surrendered for Adoption," or "Neonatal Death" (excluding created in error)
 - b. Person has any number greater than 0 in "Number of live births"
 - c. "Is youth parenting" question in the Family Case Plan is Yes\
- 2. **Defect #59180:** Update the "Pregnant/Parenting Youth" and "Pregnant/Parenting Youth in Custody" badges to display:

- a. When the new question, "How many are they currently/actively parenting?" is answered with any value except null or None.
- b. Badges will continue to display based on Number of Living Biological/Adoptive Children is not null or the person has a non-end-dated Pregnancy record.
- 3. **Defect #58828:** Person Snapshot records will be adjusted to account for new questions being added (Has this person ever fathered or given birth to any children?/How many children?/How many are they currently/actively parenting?)
- 4. **Defect #58831:** Person Merge records will be adjusted to account for new questions being added (Has this person ever fathered or given birth to any children?/How many children?/How many are they currently/actively parenting?)
- 5. **Defect #58833:** Impacts of new questions on RTIS functionality. Research will be done to determine if changes to existing parenting question in RTIS needs to be adjusted.
- 6. Defect #58832: Impact on Adoption Seal
 - a. The new series of questions (on person) will copy to the new person ID.
 - b. The question "Has this person ever fathered or given birth to any children?" must be answered.
 - c. Validation will display when the Seal/Secure button is selected.
 - i. Validation message: "The question Has this person ever fathered or given birth to any children? (Person > Medical > Pregnancy / Parenting Tab)" has not been answered.

Homestudy Impacts

- 1. Defect #59217 (*Element 121 Location of Living Arrangement/122 Jurisdiction or Country Where Child is Living*): Adds a check/validation to the Homestudy approval for valid provider address
 - a. Validation message: "Physical or Residence Address type cannot be deleted or end-dated"
- 2. Defect #58869 (Element 135 Sex of First Foster Parent/Element 146 Sex of Second Foster Parent: Adds a validation message to Homestudy if Gender is missing for any of the applicants
 - a. Validation message: "Gender is missing for Applicant 1-5"
- 3. **Defect #59215** *(Element 123 Marital Status of Foster Parents)*: Adds "Separated" as a new value to the Household Marital Status section of the Homestudy.
