AFCARS 2020 Elements 72-105 Child and Family Circumstances at Removal correspond to the Removal Reasons on the Initial Removal SACWIS page. The chart below details the changes to both available Removal Reason values in SACWIS and the Removal Reasons to be added and how those values will map to the revised Child and Family Circumstances at Removal values in AFCARS 2020.

Custody Relinquishment-Mental Health Treatment	N	The child and/or child's family has inadequate resources to access the necessary mental health services outside of the child's out-of-home care placement. This value should only be selected when the custody is being relinquished solely for the purpose of affording needed treatment for the child.
Custody Relinquishment for Adoption - (Not Safe Haven)	N	The child's parent has voluntarily relinquished the child by assigning the physical and legal custody of the child to the title IV-E agency, in writing, for the purpose of having the child adopted.
