Ohio SACWIS-RTIS Release 4.27

Background

Ohio SACWIS / RTIS deploys changes around every 7 weeks to improve the user experience and deploy new functionality. The 4.27 Release contains another phase of KGAP functionality described below which will further automate the process.

Contents of Deployment

Person Module:

• When a user saves from the Person Basic tab, all changes entered on the Demographics page are now saved correctly.

Intake Module:

- When an intake is unlinked from an Adoption case, all AI Members added or reactivated when the intake was linked to the case are removed or updated accordingly.
- The CAPM Safety Assessment functionality has been updated to no longer require child vulnerability information when a child has been marked deceased on their person record.

Case Module:

- The Living Arrangement functionality has been updated to:
 - Add two new end reasons
 - Record a Living Arrangement on a closed case
 - Add a new Living Arrangement type of Non-Custodial Parent
- The Placement functionality has been updated to enable Non-Custodial Parent records for both an Alleged Mother and Alleged Father.
- The Family Case Plan functionality was updated to record Court Status and Court File Dates after Family Case Plan approval.

Provider Module:

- The Activity Log functionality has been updated to include 'KGAP' in the dropdown values for Category and Subcategory.
- The Copy/Move Provider Information Utility was updated to include KGAP values.

Administration Module:

• Placement notifications for the placements which were added and ended at the same time have been updated to correctly notify placement workers.

Financial Module:

- KGAP Workload functionality has been added.
- KGAP Activity Log functionality has been added.
- Defect resolution for the KGAP reviews have also been incorporated into this build.

Reporting Module:

The following reports will be delivered to support KGAP:

- <u>**RPT 599 Title IV-E KGAP C21 Notice of Redetermination** (*New*) This report is based on JFS00140 and serves as a notice inform Kinship Caregiver that it's time to redetermine eligibility for the young adult. This report generates from the KGAP record in the Finance area/module.</u>
- <u>**RPT 602 Title IV-E KGAP C21 Notice of Continued Approval** (*New*) This report is based on JFS 00144 and is a notification to Kinship Caregiver that young adult continues to be eligible for KGAP C21 program. This report generates from the Finance area/module.</u>
- <u>**RPT 600 C21 Title IV-E KGAP C21 Young Adult Semi-Annual Assurance of Kinship Caregiver Responsibility and Eligibility for Continued Medicaid Coverage** (*New*) This report is based on JFS 00141 and is generated semi-annually for completion by the young adult to ensure their KGAP eligibility and continued Medicaid coverage. This report generates from the Finance area/module.</u>
- <u>RPT 610 Title IV-E KGAP C21 Kinship Caregiver Semi-Annual Assurance of Kinship Caregiver Responsibility and Eligibility for Continued Medicaid Coverage</u> (*New*) This report is based on JFS 00141 and is generated semi-annually for completion by the kinship caregiver to ensure the young adult's KGAP eligibility and continued Medicaid coverage. This report generates from the Finance area/module.
- <u>RPT 596 Title IV-E KGAP Annual Assurance of Legal Responsibility, School</u> <u>Attendance and Eligibility for Continued Medicaid Coverage</u> (*New*) – This report is based on JFS 00136 and is generated for annual completion by the Kinship Caregiver(s) to ensure child's KGAP eligibility and continued Medicaid coverage. This report generates from the KGAP record in the Finance area/module.
- <u>**RPT 603 KGAP OWF Compliance**</u> (*New*) This KGAP Administrative Report helps workers to determine if OWF compliance is met for all children that are receiving a KGAP Subsidy. This report generates from the Administrative/Reports area.
- <u>**RPT 606 Potential KGAP Children**</u> (*Enhancement*) An update to this report displays the Person ID of the sibling receiving KGAP and insert the restricted case rule. This report generates from the Administrative/Reports area.
- <u>**RPT 592 Title IV-E KGAP C21 Agreement**</u> (*Enhancement*) An update to the parameter page for this report allows workers to enter the Title XX social services the child is receiving which populate on the report. This report generates from the Finance area/module.

Deployment Details:

Release 4.27 will be deployed into the production environment July 2023.
