This article describes how to locate information on Children's Residential Centers (CRC), Residential Parenting Facility (RPF), Children's Crisis Care Facility (CCF), and Group Home (GH) facilities that are used for placements in SACWIS and are linked to an Agency Certification record.

Note: When placing a child in one of these facilities, please link the Provider ID of the facility to the placement. No placements are to be linked to the Network Provider ID.

Locating information on CRC and GH Facilities

- 1. From the Ohio SACWIS home page, click the **Provider** Tab.
- 2. Click the Agency Certifications sub-tab.

- 5. A selection from **Certifying Entity** drop-down menu is optional and can be made to narrow down the results.

The Maintain Facilities screen appears. The screen consists of the

Approval/Certification Information grid, which displays details of the Agency's Approval/Certification, and the **Facilities Information** grid, which lists each GH or CRC facility linked to the Agency Certification. The Provider ID, displayed in the **Provider Name/ID** column of the **Facilities Information** grid, is the ID that should be linked to a placement record of the child that has been placed in that facility.

Note: If necessary, click the **view** hyperlink in the **Facilities Information** grid to verify the information of the facility.



Important: Be certain to write down, or copy and paste, the Provider ID of the placement facility before you leave this screen, so it is readily available when the placement record on the child's case is being completed.
