Generating a FAFSA Letter

This Knowledge Base Article discusses how to access and generate a **Free Application for Federal Student Aid (FAFSA)** letter. An agency can provide this letter to any youth who is emancipating from foster care and has shown an interest in attending college.

Important:

- The FAFSA letter can be printed on your agency's letterhead.
- Regardless of which agency was responsible for the youth's placement, any agency can generate the FAFSA letter for any youth who is requesting verification.
- 1. On the SACWIS Home screen, click the Case tab.
- 2. Click the Workload tab. The Case Workload screen appears.
- 3. Select the appropriate Case ID link.
