#### Overview

This document provides information about the Residential Treatment Information System (RTIS) for a youth placed in a Residential Treatment Program.

Ohio RTIS is navigated in a similar way to Web-based, online forms. The application appears in a Web browser. The forms in the application contain many of the field and navigation features seen in PC or Web-based applications.

#### Note:

**DO NOT** open more than one browser window or tab of Ohio RTIS at a time. Multiple concurrent sessions of Ohio RTIS can potentially cause data corruption and sensitive information to be attached to the wrong case or child.

(If you want to copy narratives from one record to another, copy the text and paste it in a Word or text file. Then copy it from the Word or text file and paste it into the new location.)

# **Navigating within Ohio RTIS**

The browser's navigation bar appears above the Ohio RTIS menu. Remember, the tools in the browser are used for navigating the Internet or an Intranet. These tools do not control the functions within Ohio RTIS and should not be used while you're in the system.

Important: DO NOT use the Back and Forward buttons in your browser's navigation bar. Use only the buttons and links within the application screen to move from one screen to another. Use only the log off link to close Ohio RTIS, not the X in your web browser window.

**Important:** To navigate in Ohio RTIS, you will click the buttons, or select from the links provided on the screen. To get out of a record, or off a screen, you will select from the buttons. **You must use these as alternatives to the Back arrow, or button:** 

- Click the **Apply** button. This applies the data entered to the record, takes you to the top of the screen within the record so you can continue in the process task.
- Click the Save button. This saves the data entered to the record and takes you
  out of the record.
- Click the **Cancel** button and click OK in the dialog box. This returns you to the previous screen, or the filter/list screen without changing any data.
- Click the Close button. The returns you to the previous screen (see Apply, Save, Cancel, Close.)

#### **Header and Footer**

Regardless of where you are in Ohio RTIS, certain buttons and links always appear at the top and bottom of the screen. These are the header and footer links and buttons. Each button has links that navigate to specific areas within the button selected.

If you are entering information on a screen, and want the information saved to the record, be sure to click the save button before clicking on the options in the header, footer, or another primary tab, or navigation link.

#### **The Dashboard Screen**

When you first login, you arrive at the **Dashboard** tab, or **Dashboard** screen. You can also return to this screen from any screen by clicking the **Dashboard** tab or header button. The **Dashboard** screen allows you to view messages; and navigate Action Items and Pending Approvals.


The Dashboard screen displays three additional tabs:

To navigate the Ohio RTIS Dashboard, complete the following steps:

#### Navigating the Ohio RTIS Dashboard Recently Accessed Drop Down

1. From the **Ohio RTIS Dashboard** screen, click the **Recent** drop-down menu.

The **Recently Accessed** dropdown screen appears displaying the last 15 records with most recently accessed record at the top of the list.




# Navigating the Ohio RTIS Dashboard Help Drop-Down Screen

Note: Ohio RTIS Users will contact the SACWIS Help Desk for assistance with Ohio RTIS.

- 1. From the **Ohio RTIS Home** screen, click **Help**.
- 2. The Help drop-down menu appears, displaying access to Help Desk, Knowledge Base Training, Rules, Regulations & Policy, and Privacy & Security.
- 3. Select **Help Desk** from the **Help** drop-down menu.



#### The Contact Help Desk grid appears.



If you select **Knowledge Base and Training** from the **Help** drop-down menu:

The SACWIS Knowledge Base and Web Based Training will appear as you will be navigated to <a href="https://jfskb.com/sacwis/">https://jfskb.com/sacwis/</a>.

If you select Rules, Regulation & Policy from the Help drop-down menu:

The Policy Directory for Ohio SACWIS Users will appear as you will be navigated to https://emanuals.ifs.ohio.gov/FamChild/FCASM/.

If you select **Privacy & Security** from the **Help** drop-down menu:

The Ohio RTIS Privacy & Security message will appear.




#### **Privacy & Security**

1. From the Ohio RTIS Home screen, click the Employee drop-down menu.

The Employee's Name will display along with the logged in agency, environment, and version. The Employee's last login will display. (See RM48L, RTIS Log In for information on Switch Profile and Log Off).




## **Navigating the Ohio RTIS Dashboard Tab**

#### From the RTIS Home Screen


Click the **Dashboard** Tab.

The Dashboard will display the ODJFS Broadcast Messages and any Action Items or Pending Approvals associated to the logged-in Employee.

- Ohio RTIS Dashboard Broadcast Message Broadcast messages will be posted by State Staff to alert you of any known system issues, planned outages, and other important information that needs to be shared with all Ohio RTIS users.
- Ohio RTIS Dashboard Action Items Action items will list any work items that are nearing their due date and any past due items.



Ohio RTIS Dashboard Pending Approvals – The pending approvals screen will list any work items you have routed to a supervisor for approval or any work items that have been routed to you for approval as a supervisor. (See the Knowledge Base Aritcle titled [blah blah bla} for more information on routing work items for approval)
