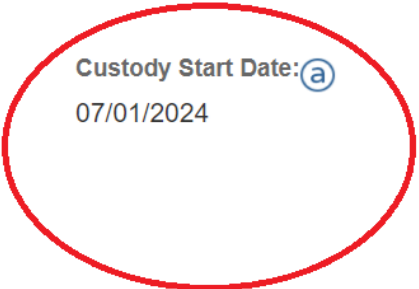

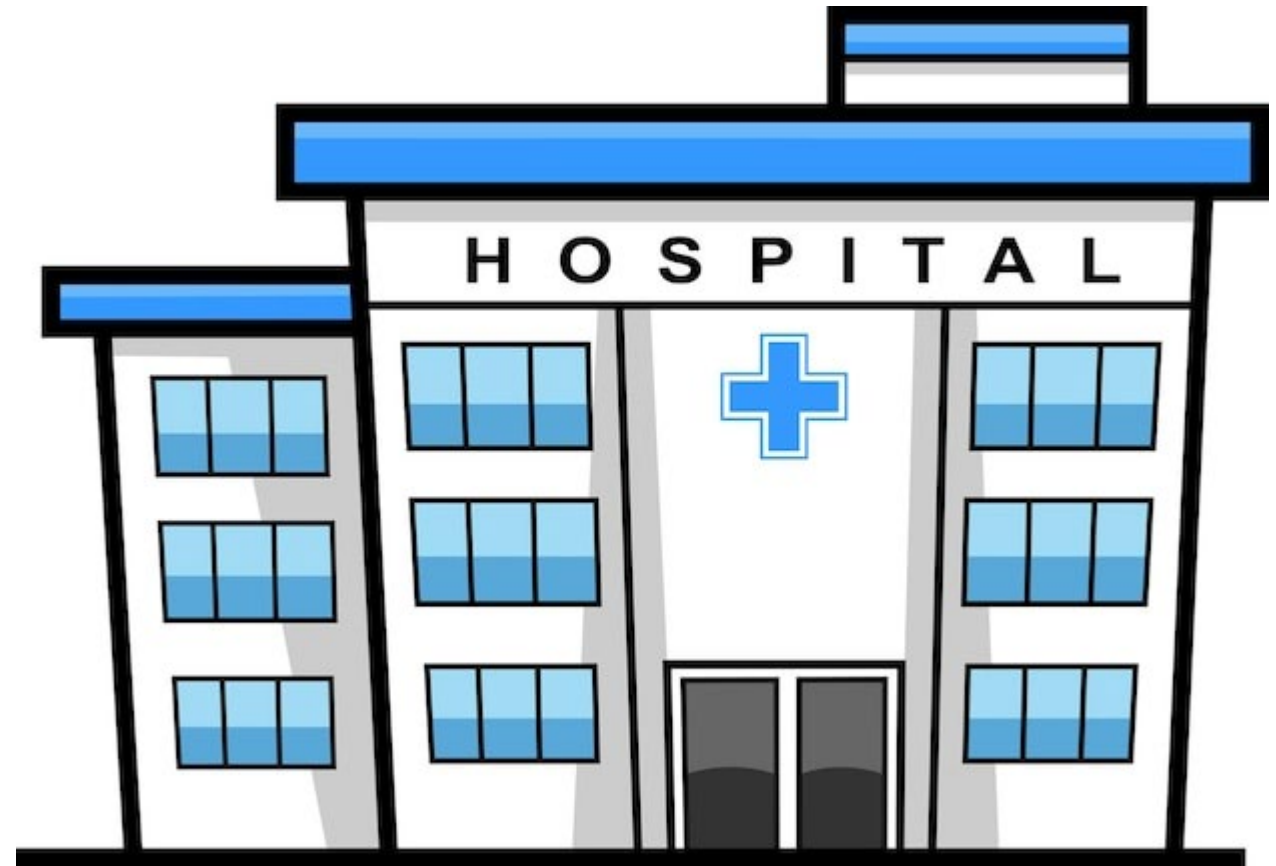

Addition of PRTF Placement Type

- New Placement Type
 - Psychological Residential Treatment Facility has been added as a placement type when matching providers
 - These providers are handled through Medicaid and will be maintained by the state
 - Preparation for future updates

- Located in Certified/Approved
