Background

Ohio SACWIS/RTIS deploys changes around every 7 weeks to improve the user experience and deploy new functionality. The 4.28 Release contains another phase of KGAP functionality described below which will further automate the process.

Contents of Deployment

Person Module:

- Person Relationship functionality has been updated. Many person relationship records are missing reciprocal relationships. These relationships will be corrected, and reciprocal relationships added for these person profiles.

Intake Module:

- Record Intake functionality has been updated to improve warning messages for adoption case members. System warning message displays when one or more ACVs/CSRs is an adoption case member and there are ACVs/CSRs who are not members of the same adoption case. Intakes cannot be linked to an adoption case if there are ACVs/CSRs who are not members of the adoption case.
- Unlink Intake functionality has been updated. Intakes are unable to be unlinked from a case if a legal status/legal action was created during the case episode. The system will allow intakes to be unlinked if they were added to a case which has already existing legal status/legal action.

Case Module:

- Case Review functionality has been updated to:
 - Show the concern topic even when all concerns within the Family Case Plan have been end dated
 - Correctly pull in Previous Safety Responses and Previous Safety Factor Responses from the most recent safety assessment or reassessment.
- SAR Functionality has been updated to:
 - Correctly show the Independent Living Topic as Completed when all requirements are met.
 - Update the wording in the Concurrent Plan Narrative Box to remove duplicate entry of information.
- The Activity Log functionality has been updated and will no longer allow the user to save when the start date is greater than the end date. Historically, the system has automatically changed the date so the start and end dates match.
- There will be a new Action Item that will display when a youth in agency custody turns 14 years old to prompt the user to create an Active Independent Living Plan.

Financial Module:

- The 4.28 phase of KGAP functionality primarily impacts JFS State staff who are maintaining the program. These enhancements include improvements that allow for ease of creating KGAP records for Successor Guardians, KGAP Connections to 21 and KGAP Nonrecurring. There are also improvements in how Foster Care Maintenance used for KGAP subsidy will be calculated.
- *For Custodial agencies* completing KGAP Eligibility- When adding a successor guardian to the KGAP Eligibility record, the system will validate that the person linked is at least 18 years old and will let the user know if a date of birth is not recorded. A close button was also added to the KGAP Filter screen when the user navigates via Workload to allow the user to click ‘Close’ and return to their workload items list. Lastly, in Question #6 for KGAP Eligibility, users will notice that the system will now display all case plans for the child that were approved as of the KGAP Application date *and after*. All case plans must meet KGAP Eligibility criteria.

63262	RPT 589 FEDERAL KGAP AGREEMENT (Enhancement) - This report is based on the revised JFS 00133. The enhancement removes the word 'primary' from successor guardian and adds language to Article V: Medical Care. This report generates from the Finance area/module.
63044	RPT 611 KGAP PAYMENT EXCEPTION REPORT (New Parameter) - This is the functional parameter page for the new KGAP Payment Exception Report. This report link is in the Administrative/Reports area.
